## 2023 SPRING REBATE!

### Eligibility

Purchase a minimum of \$1,000 of Breezesta premium furniture between February 1 and March 31, 2023 from a participating dealer and qualify for a rebate. You can receive \$100 off per each \$1,000 spent with an authorized Breezesta reseller either in store or online, up to a maximum rebate amount of \$1,000 with a minimum \$10,000 purchase. See rebate tiers below. Offer valid only on a new Breezesta retail order that generates a new Casual Living Unlimited (CLU) order. Offer not valid on in-stock merchandise. **Dealer must place eligible orders with CLU between February 1, 2023 and March 31, 2023.**

### Redemption Instructions

Print this page and give to the dealer or have the dealer reference this page prior to ordering and rendering payment for Breezesta furniture. If the dealer chooses to participate, the dealer will file a claim for the rebate with Breezesta by completing the digital form at [www.breezesta.com/rebateform](http://www.breezesta.com/rebateform).

### Terms and Conditions

This program requires dealer financial participation. Participating dealers are encouraged to provide the rebate as a discount at point of purchase prior to completing and submitting a redemption form with Casual Living Unlimited (CLU). Offer valid only on new CLU orders between February 1 and March 31, 2023. Participating dealers placing a new special order or Quick Ship order for customers who are using the Spring Rebate must pay the respective CLU invoice first and then submit the digital redemption form in order to receive an account credit. No cash or checks will be given. Credit invoices will be sent to dealers. Redemption/ rebate reimbursement is limited to \$75 per every \$1,000 of Breezesta furniture sold at retail. **Dealers file for the rebate by completing the rebate redemption form located at [www.breezesta.com/rebateform](http://www.breezesta.com/rebateform)**. Redemption requirements include:

1. Copy of the detailed order, receipt, or invoice given to the dealer’s customer clearly showing the furniture sold and the rebate amount being subtracted from the total.
2. CLU invoice number(s) containing the items sold that are eligible for rebate under this offer. Alternatively, the respective CLU order numbers are acceptable.

Rebate eligibility will be forfeited if all information is not provided. **REBATE CLAIMS MUST BE SUBMITTED BY MAY 31, 2023.**
